*Affordable Connectivity Program.*

You could receive \$75 toward your Internet bill if you live on Tribal Lands or \$30 if you do not.

**\$100 Million** Coronavirus Capital Projects Fund from American Rescue Plan of 2021 for work, education, and health monitoring, including remote options. [Request funds here.](#)






States Economic Development Assistance Fund
